EC LITERACY GOAL

Board Outcome Goal 1: EC Literacy

The percent of 3rd Grade students that score meets grade level or above on **STAAR Reading** will increase from 44% to 60% by June 2029.

Progress Measure 1.1: The percentage of Kinder students that score "on track" on the TX-KEA literacy diagnostic will increase from 52% to 70% by June 2029.

Progress Measure 1.2: The percentage of 3rd Grade students that score "on track" (Proficient) on HMH Literacy diagnostic will increase from 51% to 65% by June 2029

Progress Measure 1.3: The percentage of 1st through 2nd grade students that score "developed" on TPRI/Tejas Lee diagnostic will increase from 18% to 60% by June 2029.

EC MATH GOAL

Progress Measure 1.2: The percentage of students 1st – 2nd Grades that score "on track" on IXL diagnostics (BOY, MOY, EOY) will increase from 57% to 75% by June 2029.

Progress Measure 1.3: The percentage of 3rd grade students that score Meets or above on STAAR Interim will increase from 30% to 60% by June 2029.
